ที่ ๕๖/๒๕๖๔

เรื่อง หลักเกณฑ์และพิธีการการยกเว้นอากรและลดอัตราอากรศุลกากร
สำหรับของที่มีถิ่นกำเนิดจากออสเตรเลีย (ฉบับที่ ๓)

เพื่อปฏิบัติตามข้อผูกพันตามความตกลงการค้าเสรีไทย - ออสเตรเลีย (Thailand - Australia Free Trade Agreement) และเพื่อให้เป็นไปตามประกาศกระทรวงการคลัง เรื่อง การยกเว้นอากรและลดอัตราอากรศุลกากรสำหรับของที่มีถิ่นกำเนิดจากออสเตรเลีย ลงวันที่ ๒๘ ธันวาคม พ.ศ. ๒๕๖๔ ซึ่งให้ยกเว้นและลดอัตราอากรสำหรับของที่มีถิ่นกำเนิดจากออสเตรเลีย โดยให้ปฏิบัติพิธีการศุลกากรตามที่อธิบดีกรมศุลกากรกำหนด

อาศัยอำนาจตามความในมาตรา ๗ มาตรา ๒๕ มาตรา ๕๑ และมาตรา ๖๓ แห่งพระราชบัญญัติศุลกากร พ.ศ. ๒๕๖๐ อธิบดีกรมศุลกากรจึงออกประกาศไว้ ดังต่อไปนี้
